S2017 – LF1 – Resolution on Vetting Foreign Nationals from Designated Nations

Whereas under President Obama numerous refugees and immigrants were allowed into our nation, and

Whereas, at least 72 individuals from Somalia, Yemen, Syria, Libya, Iran, Sudan and Iraq were convicted of terrorism or planning terrorist attacks in our country, and

Whereas, the United States Congress listed these countries as countries of concern on the issue of terrorism, and

Whereas, security experts in our country have made clear that these nations do not have the ability to do the proper vetting of their populations, and

Whereas, a temporary moratorium on immigration and visas was ordered until a system of extreme vetting can be designed and be put in place, and

Whereas, the primary responsibility of any government is to protect its citizens,

Therefore be it resolved that the California Republican Party fully supports the efforts of President Trump to assure that individuals from Somalia, Yemen, Syria, Libya, Iran, Sudan and Iraq wanting to enter our country in any status are fully vetted to ensure that no additional terrorists or terrorist supporters enter into the United States.

S2017 – LF2 – Resolution to Repeal and Replace ObamaCare

Whereas, this year Californians involved under ObamaCare will pay an average of 13% more, with larger deductibles, while our Arizona neighbor had increases of over 100% and Minnesota had increases of 53%, both with larger deductibles, and

Whereas, fewer doctors and hospitals wish to participate, insurance companies have announced withdrawals from the program and one of the first Executive Orders issued by President Trump was to tell the IRS not to fine anyone for not buying high priced, mediocre health care under this program, and

Whereas, Tom Price, the new Secretary of Health and Human Services, along with others in Congress have plans that are being consolidated for the immediate replacement of ObamaCare, and

Whereas some of these ideas include allowing citizens to buy health insurance across state lines, allow for expanded privately held health care fund accounts, allowing parents to keep children up to age 26 on insurance policies and keeping people with preexisting conditions on insurance policies,

Therefore, be it resolved that the California Republican Party urges its delegation to Congress to push for the repeal and replacement of ObamaCare as soon as possible, within the first 100 days of the Trump Administration.

S2017 – LF4 – Resolution Regarding "Sanctuary" Jurisdictions
