



RESOLUTION TO HOLD PRESIDENT BIDEN ACCOUNTABLE FOR THE BORDER CRISIS

WHEREAS, The President of the United States has a duty under Article II of our Constitution to take care that the laws be faithfully executed and as Commander-in-Chief of our armed forces, must protect the country;

WHEREAS, The Republican Party successfully took the House majority in the 2022 midterm election cycle and can now initiate investigations into the Biden administration's failure to secure our southern border;

WHEREAS, The Biden administration's policies have resulted in the largest number of monthly southern border encounters on record: 233,740 in November 2022, including 13,150 unaccompanied children;

WHEREAS, Over 5 million illegal aliens have crossed the southern border since the beginning of the Biden administration, including gang members and over 98 apprehended who were on the terrorist watch list;

WHEREAS, Drug overdose deaths have reached an all-time high due in large part to drugs pouring across the southern border, with over 25,000 pounds of fentanyl being seized at the southern border since President Biden took office;

WHEREAS, Fentanyl is the leading cause of death for 18 to 45 year old Americans;

WHEREAS, The Biden administration released tens of thousands of illegal aliens into the United States without ordering them to appear in court for immigration hearings on specific dates and allowed illegal aliens who tested positive for the coronavirus to enter the United States;

WHEREAS, Human smuggling and trafficking, enabled by President Biden's border policies, create an estimated \$1 billion per month industry for smugglers and traffickers; and

WHEREAS, President Biden's neglect of the border crisis is a failure to maintain and defend American sovereignty; therefore, be it

RESOLVED, That the Republican National Committee urges Congress to conduct a full investigation into all aspects of the Biden administration's handling of the southern border and, if the facts support it, taking all appropriate action against administration officials found derelict in their duty to protect the homeland, up to and including impeachment; and

RESOLVED, That the Republican National Committee encourages Congress to take any and all additional legislative measures to secure our borders from dangers to Americans.





RESOLUTION TO OFFICIALLY OPPOSE RANKED CHOICE VOTING ACROSS THE COUNTRY

WHEREAS, The mission of the Republican Party is to act as the party of liberty, the party of equality, the party of opportunity for all, the party of favoritism for none and to encourage and allow the broadest possible participation of all voters in Republican Party activities at all levels and to ensure that the Republican Party is open and accessible to all Americans;

WHEREAS, America has operated on a well-understood and relatively uniform election system that has been implemented over two hundred years to support our constitutional republic;

WHEREAS, The political parties in America have created the world's largest representative forums for debate amongst thousands of factions of American citizens all across the nation;

WHEREAS, Traditional American primary and general elections ensure that voters who support one candidate, not a plurality of candidates, are heard clearly while ranked choice voting schemes open elections to 'ballot exhaustion' or the disenfranchisement of voters who choose not to support multiple candidates who do not clearly represent their values;

WHEREAS, The grassroots activists of the Republican Party have made it abundantly clear that they do not trust new election procedures, outcomes, and further complications of modern systems that sow additional distrust in elections and we need to keep voting simple and secure;

WHEREAS, Educating voters on the confusing processes that vary by state has cost taxpayers tens of millions of dollars for educational efforts that have provided ineffective results;

WHEREAS, States and communities where ranked choice voting has been tested have consistently decreased voter participation in those communities and in many cases the elections have resulted in more discarded votes than counted votes;

WHEREAS, Ranked choice voting often results in additional tabulation delays resulting in days or weeks of additional counting while depending exclusively on technology without traceable ballots to support determined winners; and

WHEREAS, Supporters of ranked choice voting seek to eliminate or disempower party primaries; therefore, be it

RESOLVED, That the Republican National Committee rejects ranked choice voting and similar schemes that increase election distrust, and voter suppression and disenfranchisement, eliminate the historic political party system, and put elections in the hands of expensive election schemes that cost taxpayers and depend exclusively on confusing technology and unelected bureaucrats to manage it; and

RESOLVED, That the Republican National Committee calls on Congress, state legislatures, and voters to oppose ranked choice voting in every locality and level of government and return elections to easier systems that have worked for centuries for fair and transparent elections.





**RESOLUTION HONORING AND CELEBRATING THE LIFE AND LEGACY OF
CONGRESSMAN DON YOUNG**

WHEREAS, Congressman Don Young was born on June 9, 1933, in Meridian, California, and earned an associate degree from Yuba Junior College and a bachelor's degree in teaching from Chico State University;

WHEREAS, Congressman Don Young served in the Army as part of the 41st Tank Battalion from 1955 to 1957 before moving to Alaska in 1959 and finding his lasting home in the village of Fort Yukon, seven miles above the Arctic Circle;

WHEREAS, Congressman Don Young met and married the first love of his life, Lula "Lu" Young, in Fort Yukon, and together they had two lovely daughters, Dawn and Joni, and later 14 grandchildren;

WHEREAS, Congressman Don Young taught fifth grade at a school run by the Bureau of Indian Affairs during the winter, and worked in construction, mining, fishing, and trapping, and as a tugboat captain in the warmer months;

WHEREAS, Congressman Don Young was elected mayor of Fort Yukon in 1964 and served in that role until 1967, when he was elected to and served in the Alaska House of Representatives from 1967 to 1970 and then in the Alaska State Senate from 1971 to 1973;

WHEREAS, Congressman Don Young was elected to the US House of Representatives in 1973 in a special election and served 24 additional and consecutive terms;

WHEREAS, As a freshman in Congress, Congressman Don Young fought for the Trans-Alaska Pipeline, which now carries an average of 1.8 million barrels of oil per day, saying that the pipeline was one of his most significant achievements as a Representative;

WHEREAS, For these efforts Congressman Don Young was named "Freshman Congressman of the Year" in 1973;

WHEREAS, Congressman Don Young served as Chairman of the Committee on Natural Resources of the House of Representatives from 1995 to 2001, and the Committee on Transportation and Infrastructure of the House of Representatives from 2001 to 2007;

WHEREAS, Congressman Don Young was a champion for Alaska native peoples, including as chairman of the Subcommittee on Indian, Insular and Alaska Native Affairs of the House Committee on Natural Resources;

WHEREAS, Congressman Don Young fiercely defended Alaska and Alaskans as the sole Representative for the largest State in the United States and devoted himself to fulfilling the immense promise of his home State;

WHEREAS, Congressman Don Young was a leader in strengthening the role of Alaska in providing for the national defense of the United States through his support for the Coast Guard, the Alaskan Command, and the ballistic missile defense and his steadfast commitment to the leadership of the United States in the Arctic;

WHEREAS, Congressman Don Young managed to secure billions of dollars for projects that benefitted the State of Alaska, and pushed legislation and policies that built roads and pipelines, restricted purchases of conservation lands, and limited the reach of burdensome Federal rules;



Resolution #3

As Adopted by the Resolutions Committee

WHEREAS, Congressman Don Young, representing a State known for its natural beauty, wildlife, ecology, and environment, pushed back against Federal control of Alaskan lands, established a 200-mile fishing limit to support the State's fishing industry, and helped pass the National Wildlife Refuge System Improvement Act of 1997, which set guidelines for wildlife refuges;

WHEREAS, Congressman Don Young was the sponsor or cosponsor of 658 bills that have become law through the House of Representatives, including being the primary sponsor of 127 bills that were enacted, and 87 bills that became law;

WHEREAS, Congressman Don Young's legislative achievements spanned the policy spectrum, as he formed strong relationships and friendships with members on both sides of the aisle, and he proudly worked with ten different presidents;

WHEREAS, Congressman Don Young married his second love, Anne Garland Walton, in 2015, in the United States Capitol;

WHEREAS, On December 5, 2017, Congressman Don Young became the 45th Dean of the House of Representatives, reflecting his status as its most senior member;

WHEREAS, Congressman Don Young was the longest-serving Republican in the history of Congress; and

WHEREAS Representative Young ultimately served the 49th State with dedication and distinction for 49 years and 13 days, which is more than three fourths of the period in which Alaska has been a state; therefore, be it

RESOLVED, That the Republican National Committee joins the Alaska Republican Party in mourning the death of Don Young, congressman for all Alaska and the 45th Dean of the House of Representatives, and hereby honors his lifetime of service to Alaska, the Republican Party, and the United States.



RESOLUTION TO OPPOSE ALL FORMS OF ANTISEMITISM, ANTISEMITIC STATEMENTS, AND ANY ANTISEMITIC ELEMENTS THAT SEEK TO INFILTRATE THE REPUBLICAN PARTY

WHEREAS, America was founded on the self-evident principle defined in the Declaration of Independence that “all men are created equal”;

WHEREAS, The Republican Party was founded for the purpose of fulfilling the promise of the Declaration of Independence;

WHEREAS, The Republican Party stands for freedom, prosperity, and opportunity for all people regardless of race, religion, sex, creed, disability, or national origin;

WHEREAS, The Republican Party platform formally denounces bigotry, racism, antisemitism, ethnic prejudice, and religious intolerance;

WHEREAS, The scourge of antisemitism, anti-Israel hatred, Holocaust-denial, and bigotry against the Jewish people is growing, represents a direct threat to all people, and is antithetical to our American principles, the U.S. Constitution, and the platform of the Republican Party;

WHEREAS, In the words of former Republican United States Senator Norm Coleman, “Antisemitism is an evil ... not confined to one time, one place, or one ideology. It is woven out of lies about Jews and our history and feeds on hatred, fear, and jealousy”;

WHEREAS, Rapper Ye, formerly known as Kanye West, has repeatedly made statements that are antisemitic, shameful, wrong, offensive, bigoted, and contrary to American and Republican principles, among these statements, “the Jewish media has made us feel like the Nazis and Hitler have never offered anything of value to the world... we’ve got to stop dissing the Nazis all of the time”;

WHEREAS, White supremacist Nicholas “Nick” Fuentes has repeatedly made statements that are antisemitic, shameful, wrong, offensive, bigoted, and contrary to American and Republican principles, among these laughingly comparing Jews killed at concentration camps to baking cookies in an oven;

WHEREAS, University and college campuses dominated by progressives have become centers of a new wave of antisemitism;

WHEREAS, A report from the Louis D. Brandeis Center for Human Rights Under Law found more than half of Jewish college students say they felt the need to hide their Jewish identity on campus;



Resolution #4

WHEREAS, The Democrat Party has embraced antisemitic politicians, including Congresswomen Ilhan Omar, Rashida Tlaib, Cori Bush, and many others who have spread vile hatred of the Jewish people with impunity;

WHEREAS, Democrat Congresswoman Ilhan Omar has repeatedly made statements that are antisemitic, shameful, wrong, offensive, bigoted, and contrary to American principles, among these “Israel has hypnotized the world”;

WHEREAS, Democrat Congresswoman Rashida Tlaib has publicly denounced Israel, saying “we need to stop enabling” them and has made antisemitic statements such as how she got a “calming feeling” when discussing the Holocaust;

WHEREAS, Democrat Congresswoman Cori Bush has been an outspoken supporter of the antisemitic BDS movement and refused to grant an interview to a local Jewish newspaper in her district;

WHEREAS, Democrat Representatives including Barbara Lee, Maxine Waters, Danny Davis, Andre Carson, Gregory Meeks, Jim Clyburn, Al Green, and Senator Raphael Warnock have ties to or have spoken positively of antisemites and antisemitic organizations;

WHEREAS, Journalist Bari Weiss writes in her book, *How to Fight Anti-Semitism*, “to be a good progressive increasingly requires distorting Jewish history and disavowing the Jewish state”;

WHEREAS, In the 1950s, when antisemitic groups attempted to gain traction among some conservatives, William F. Buckley, the intellectual godfather of the modern conservative movement, responded by adopting a “hypersensitivity to antisemitism”; therefore, be it

RESOLVED, That the Republican National Committee shall hereby formally condemn, denounce, censure and oppose all forms of bigotry, racism, ethnic prejudice, religious intolerance, antisemitism, antisemitic statements, and any antisemitic elements that seek to infiltrate the Republican Party;

RESOLVED, That the Republican National Committee formally condemns, denounces, censures and opposes Kanye West, also known as Ye, Nicholas “Nick” Fuentes, Congresswomen Ilhan Omar, Rashida Tlaib, Cori Bush and all others promoting their antisemitism beliefs; and

RESOLVED, That the Republican National Committee affirms antisemitism has no place in our political party, American politics, or any political discourse.



RESOLUTION IN SUPPORT OF THE PROTECTION OF UNITED STATES AGRICULTURAL LAND & FOOD SUPPLY CHAIN

WHEREAS, The Republican National Committee (RNC) is committed to protect the United States' critical infrastructure on behalf of its citizens;

WHEREAS, The United States food and agricultural supply chain falls within the definition of critical infrastructure;

WHEREAS, Millions of acres have been taken out of food production due to various factors;

WHEREAS, Small farmers and ranchers are facing extinction due to inflation, fuel, and fertilizer costs, drought, and issues involving foreign influence over U.S. food and agricultural supply chain;

WHEREAS, The global food and agricultural supply chain was damaged by COVID-19, including but not limited to, harvesting, logistics, processing, marketing, and sourcing, making it imperative to provide meaningful protection with respect to the United States food supply chain;

WHEREAS, Rural communities have been and are presently besieged with the extraordinary costs of defending lawsuits as companies, often owned by foreign investors, have been using litigation as part of their effort to capture tens of millions of dollars in federal tax credits related to green energy at the expense of the rural farming communities;

WHEREAS, In 2021, Texas stopped billionaire and former Chinese military official Sun Guangxin, who purchased 140,000 acres of Texas agricultural land, from building his planned wind and solar farms in close proximity to Laughlin Air Force Base by passing the Lonestar Infrastructure Protection Act;

WHEREAS, In 2013, a Chinese firm Shuanghui, now doing business as WH Group, purchased Smithfield Food, Inc. and took possession of 42,000 acres of agricultural land in Missouri, in addition to over 146,000 acres of farmland across the country, which allows it to control a significant portion of U.S. pork production;

WHEREAS, According to 2019 USDA data, foreign investment in farmlands tripled in ten years, and according to 2019 USDA data, the reason most cited by foreign entities for buying U.S. farmland is to ensure their own food security;

WHEREAS, The Agricultural Foreign Investment Disclosure Act (AFIDA) of 1978 does not ban foreign or limit foreign investment; it simply requires foreign entities to self-report their purchases of farmland to the USDA and although the Act allows for steep penalties, enforcement is rare;

WHEREAS, In 2017, there was an effort, which remains in committee, to amend Section 721 of the Defense Production Act of 1950 to: 1) include the Secretary of Agriculture and the Secretary of Health and Human Services as members of the Committee on Foreign Investment in the United States; and 2) to require the Committee to consider the security of the food and agriculture systems



of the United States as a factor to be considered when determining to take action with respect to foreign investment”;

WHEREAS, Six states ban foreign ownership of United States agricultural land and approximately 22 states have passed some regulation; however, there is no uniformity;

WHEREAS, In the State of Texas, thousands of acres have been purchased by foreign investors in the last five years;

WHEREAS, On September 15, 2022, President Biden issued an Executive Order to address national security risks of foreign investment, but in the preamble stated that “the United States welcomes and supports foreign investment, consistent with the protection of national security”;

WHEREAS, There is no uniform statutory protection with meaningful enforcement mechanisms to protect the United States food and agricultural supply chain; and

WHEREAS, There is a lack of definitive studies with respect to the potential multitude of cascading effects of foreign investment in the U.S. food and agricultural supply chain; therefore, be it

RESOLVED, That the Republican National Committee affirms that for purposes of national and state law, agricultural land is an integral part of the United States’ critical infrastructure affording it the utmost protection;

RESOLVED, There are publicized situations that have raised serious security and/or critical infrastructure alarm(s) concerning the United States food and agricultural supply chain;

RESOLVED, In order to protect the United States food and agricultural supply chain, the United States needs law on the books with teeth that stops foreign corporations from controlling the U.S. agricultural and food supply chain; and

RESOLVED, That the Republican National Committee urges Congress to take action that ensures the United States agricultural and food supply chain is protected.



RESOLUTION HONORING THE LIFE OF DR. ADA FISHER

WHEREAS, Dr. Ada Fisher was born on October 21, 1947 in Durham, North Carolina to Reverend Dr. Miles Mark Fisher and Ada Virginia Foster Fisher;

WHEREAS, Dr. Fisher served as North Carolina's National Committeewoman for more than a decade, from 2008 to 2020, and was involved with the Republican Party of North Carolina for over 40 years;

WHEREAS, Dr. Fisher worked on the Republican presidential campaigns of George W. Bush, John McCain, Mitt Romney, and Donald Trump and in 2016 served as a delegate to the Republican National Convention where she made the formal announcement that North Carolina's 29 delegate votes would go to Donald Trump;

WHEREAS, Dr. Fisher helped lead the North Carolina Black Advisory Board, which was a community outreach effort of the RNC and NCGOP and pursued an engagement strategy inclusive of age, gender, and race to significantly grow the party in North Carolina;

WHEREAS, Dr. Fisher graduated from Hillside High School in Durham with honors and earned her Bachelor of Science degree in biology from the University of North Carolina at Greensboro (UNCG) in 1970, where she was the first black alumna to receive an M.D. from that university;

WHEREAS, Dr. Fisher then attended the University of Wisconsin's School of Medicine and Public Health and in 1975 was the first black female to graduate there and went on to pursue a residency in family medicine at the University of Rochester;

WHEREAS, In 1981, Dr. Fisher earned her Master's in Public Health (MPH) from Johns Hopkins University School of Hygiene and Public Health, which transitioned her to the clinical side of medicine where she conducted research and developed policy to meet the needs of the populations she served;

WHEREAS, Dr. Fisher was a prolific writer and authored many publications including *Common Sense Conservative Prescriptions*; *Preparations to Survive A Terrorist Attack Citizens Advisory*; *A Short History of African Americans in the North Carolina Republican Party*, as well as a frequent contributor to the Carolina Times as *Spectacles: A Closer Look*, was a guest columnist for the Salisbury Post, and is credited with 12 professional medical articles;

WHEREAS, Dr. Ada Fisher is survived by her sons Shevin Michael Fisher and Charles Malvern Fisher and her two grandchildren, Promise Markita Lucille Fisher and DeShawn Master Fisher; and

WHEREAS, Dr. Fisher is survived by her siblings Mrs. Florida F. Parker, Dr. Miles M. Fisher, Mr. Christopher T. Fisher, sister-in-law Mrs. Janice J. Fisher, and a host of nieces, nephews, and cousins; therefore, be it

RESOLVED, That the Republican National Committee mourns the death of the unforgettable Dr. Ada Fisher and honors her lifetime of accomplishments and contributions to the Republican Party and North Carolina.





RESOLUTION AFFIRMING THE REPUBLICAN NATIONAL COMMITTEE'S COMMITMENT TO LIFE

WHEREAS, The Declaration of Independence, in its essential statement of rights that precede the institution of government, states that all human beings are created equal and endowed by the Creator with the unalienable rights to life, liberty, and the pursuit of happiness;

WHEREAS, The Republican Party, at its own foundation, declared in the original platform of 1856 that it embraced a public order that rejected “the twin relics of barbarism,” polygamy and slavery;

WHEREAS, The Republican Party has borne witness to these principles, for more than a century and a half, defending life, family, and equal justice under law for all Americans irrespective of race, ethnicity, religion, color, sex, or creed;

WHEREAS, In 1973, the Supreme Court of the United States exceeded its authority and struck down the life-protective laws enacted by the 50 states, Congress, and the territories;

WHEREAS, The Republican Party, in its 1976 platform, declared its support for the efforts of those “who seek to restore ‘protection for the right to life of unborn children’”;

WHEREAS, The Republican Party has consistently reiterated statements of support for the right to life of unborn children under our Constitution, envisioning the fostering and building of a nation where “unborn children are welcomed in life and protected in law”;

WHEREAS, The Republican Platform of 2004 made clear that the Republican Party embraces the idea that “the Fourteenth Amendment's protections apply to unborn children. Our purpose is to have legislative and judicial protection of that right against those who perform abortions”;

WHEREAS, After nearly five decades of advocacy and action by our Party against the judicial tyranny of *Roe v. Wade*, the Supreme Court in the *Dobbs* decision rightfully corrected its error, and it is now up to the people of the United States to debate and decide through their elected officials in the states, and in Congress;

WHEREAS, The Republican Party is proud to stand up for the rights of the unborn and to ensure that public policy at all levels – federal, state, local, and in the private sector – recognizes and respects both the right to life of the unborn and the role that women play in every walk of American life as leaders, citizens, and mothers;

WHEREAS, The Democratic Party has fallen away from the convictions that once led one of its greatest leaders, Gov. Robert Casey of Pennsylvania, to urge that we “extend the mantle of protection again to every member of the human family, including the unborn”;

WHEREAS, That the Democratic Party is now extreme, supporting abortion on-demand, up until birth, paid for by the taxpayer, putting their candidates far outside the mainstream;



WHEREAS, Federal policy supports the goals of protecting both mothers and babies in the womb, including measures our Party has strongly championed, including the Hyde Amendment, the Child Health Insurance Program, the Unborn Victims of Violence Act, the Partial Birth Abortion Ban Act, the Born Alive Infants Protection Act, and other measures, none of which has ever been struck down by the Supreme Court;

WHEREAS, Polling consistently shows that a majority of Americans support national, state, and local limits on abortion, with just a fringe minority supporting the Democratic position of no limits by gestational age, suspect classification, or other neutral characteristic;

WHEREAS, The Democratic Party and its allies spent hundreds of millions of dollars on the issue of abortion during the 2022 midterms, concealing their extremism while mischaracterizing and vilifying pro-life Republican candidates; and

WHEREAS, Instead of fighting back and exposing Democratic extremism on abortion, many Republican candidates failed to remind Americans of our proud heritage of challenging slavery, segregation, and the forces eroding the family and the sanctity of human life, thereby allowing Democrats to define our longtime position; therefore, be it

RESOLVED, The Republican National Committee urges all Republican pro-life candidates, consultants, and other national Republican Political Action Committees to remember this proud heritage, go on offense in the 2024 election cycle, and expose the Democrats' extreme position of supporting abortion on-demand up until the moment of birth, paid for by the taxpayers, even supporting discriminatory abortions such as gender selection or when the child has been diagnosed with Down syndrome; and

RESOLVED, The Republican National Committee urges Republican lawmakers in state legislatures and in Congress to pass the strongest pro-life legislation possible – such as laws that acknowledge the beating hearts and experiences of pain in the unborn – underscoring the new relics of barbarism the Democratic Party represents as we approach the 2024 cycle.



RESOLUTION URGING THE UNITED STATES TO SHUT DOWN ANY TYPE OF CHINESE POLICE STATION IN THE UNITED STATES

WHEREAS, It was recently revealed that over one hundred Chinese police “service stations” are present across major cities around the world, including New York City;

WHEREAS, These stations are extensions of Beijing’s efforts to pressure Chinese nationals or their relatives to return to China to face criminal charges;

WHEREAS, Chinese police stations have been linked to activities of China’s United Front Work Department, a Communist Party body charged with spreading its influence and propaganda overseas;

WHEREAS, The United States has in the past made several indictments involving the Chinese government’s harassing, stalking, surveilling, and blackmailing of people in the United States who disagreed with Chinese leader Xi Jinping;

WHEREAS, China has been known to wage surveillance and harassment campaigns against United States residents in bids for repatriation or who have been deemed criminal suspects, in what is known as “Operation Fox Hunt”;

WHEREAS, Undeclared consular activities outside of a nation's official diplomatic missions are illegal, unless a host nation has given their explicit consent; and

WHEREAS, The Director of the Federal Bureau of Investigation has stated Chinese police “service stations” violate sovereignty and circumvent standard judicial and law enforcement cooperation processes; therefore, be it

RESOLVED, The Republican National Committee urges that the law be enforced and the operation of any Chinese police station be shut down; and

RESOLVED, That certified copies of this Resolution be transmitted to members of the United States Congress, the Governors of these United States, the U.S. Department of Homeland Security, the U.S. Department of Justice, and the Federal Bureau of Investigation.





**RESOLUTION ENCOURAGING THE BAN OF TIKTOK ON FEDERAL DEVICES
AND DISCOURAGING THE USE OF TIKTOK ON PRIVATE DEVICES**

WHEREAS, TikTok is one of the fastest growing social media applications worldwide and the most popular application in the United States;

WHEREAS, TikTok boasts over one billion global users, including nearly forty percent of the United States' mobile internet users;

WHEREAS, TikTok's user base is heavily skewed towards those under the age of twenty-four;

WHEREAS, TikTok has been dubbed a form of "Digital Fentanyl" with users spending an average of an hour and a half each day on the application;

WHEREAS, TikTok's parent company, ByteDance, is headquartered in Beijing, China and under Chinese law is compelled to share their data with the government upon request;

WHEREAS, The Director of the Federal Bureau of Investigation has raised national security concerns regarding the application, asserting that China could use the app to collect data on users which could be used for espionage operations; and

WHEREAS, Due to security concerns, TikTok has been banned on government devices by the United States military, United States state departments and agencies, numerous state governments, and the United States Congress; therefore, be it

RESOLVED, That the Republican National Committee encourages the United States Congress to ban the operation of TikTok on any federal electronic devices;

RESOLVED, That the Republican National Committee discourages the download, use, or access of TikTok; and

RESOLVED, That certified copies of this resolution be transmitted to members of the United States Congress, the Federal Communications Commission, the Department of Homeland Security, the Department of Justice, and the Federal Bureau of Investigation.
