Political contributions are not tax-deductible. The maximum contribution permitted by law is \$8,100 per election per person, company or PAC (the primary election and general election are considered separate elections). A couple may contribute \$16,200 for the general 2022 election from a joint account if both parties' names are printed on the check and both parties sign the check. Contributions must be from the donor's own funds and may not be reimbursed by any other person. Contributors must be at least 18 years of age. Contributions from foreign nationals are prohibited.
