Amendment to Bylaws

Proposed amendment, strike "provided they remain neutral and do not advocate against the election of the endorsed candidate". Accepted by the makers of the motion.

Betsy Mahan called the question. 24 yes, 10 no, 1 abstention. Motion passed.

Motion passed 24 yes, 9 no, 1 abstention.

Approved language:

Section 2. Any Member may be removed without prior notice by a simple majority vote of the Central Committee at any meeting for:

(a) Affiliating or registering with another party, supporting a non-Republican candidate opposing the Republican candidate who has advanced to the general election, or advocating against support for the same, provided that such actions took place within the Member's term of office. An endorsement by the County Party does not constitute the endorsement by an individual elected officer, Member of the Executive Committee, or Ex-Officio, Regular, or Alternate Member of the County Party. Any individual elected officer, Member of the Executive Committee, or Ex-Officio, Regular, or Alternate Member of the County Party may choose to not personally endorse a candidate endorsed by the County Party, and such a choice does not constitute grounds for removal under this section; or,
