Christian Forte delivered the treasurer's report through August 31, 2024.

Report of the Chair

Chair Betsy Mahan encouraged people to vote early; the election night party will be at Brookside Restaurant and Bar, near the SCRCP office. Traffic on our SCRCP website is growing and averages @ 400 unique sessions per day. There were a total of 10,286 page views over the past 30 days, which represents 7,583 users. Our Google page is ranking on the keyword search of "Republican Party" with 3,580 coming to our page on that search since April, with 10,576 people viewing our business profile in that same time period. 306 requested directions to headquarters and 495 clicked on our website link. All of these numbers are expected to triple as the election nears.

Bylaw Amendment – Officer Duties

Christian Forte moved to approve the Bylaw Amendment; seconded by Hon. Rosario Rodriguez. Following discussion, the motion passed by unanimous vote.

Voter Outreach

Christian Forte discussed Voter Outreach for Candidates in each Supervisor District. Committee members broke up into districts and decided when to “walk” in each respective district.

Voter Guides for each of the four Assembly Districts will be available in late September; People can “Pick Up 50” to distribute in their own neighborhood, and everyone is encouraged to participate.

There is a Reception with Lanhee Chen on October 2. All Central Committee members are urged to buy tickets and attend.

October 12th is the Candidate Open House & Ballot Collection at the SCRP office.

Barbara Sloan announced community events in September including the Fair Oaks Chicken Festival and Citrus Heights Sunday Funday. Carol Fogle announced the Elk Grove Giant Pumpkin Festival taking place the first weekend in October.

Nina Caron reported on SCRP’s Election Observer program. Everyone is urged to sign up to observe vote centers during this election. Training schedules are on the Volunteer webpage.

Tanya Morales announced SCRP Candidate Services during this election.

Republican Club reports were given by the Sacramento Log Cabin Club, Sacramento Republican Women Federated, and an announcement was made that the Frederick Douglas Foundation is again active in the Sacramento area.
